

Ménière's Society 200+ Club

Your chance to win a cash prize every month!



What is the 200+ Club?

- The 200+ Club is a bit like a lottery. Participants purchase one or more shares (numbers).
- At the end of each month all the shares go into a prize draw for your chance to win a cash prize.
- The 200+ Club runs annually from May to April and is a regular and valuable contribution to the Ménière's Society's annual fundraising.
- It's a great way to raise funds and awareness for the Ménière's Society.

How much does it cost?

- One share costs £10. You can buy just one share or as many as you like. In the past one of our members purchased 30 shares! The more shares you buy the more chances you have to win.
- Shares are entered into the monthly draws for 12 months (*either from the start of the 200+ Club year in May or from the date of entering if you sign-up mid-year*).

What happens to the money raised?

- Cost and expenses are minimal, so for each £10 share sold, at least half goes to the Society and a bit less than half goes to the prize fund.
- All money raised helps us to fund research and support those affected by vestibular disorders.

How much can I win?

- Prize money is determined by the number of people taking part: the more who take part, the higher the prizes!
- In 2017/18 there were five prizes each month ranging from a top prize of £100 to fifth prize of £20.

Who can take part?

- Anyone over the age of 16 and resident in the UK can take part.
- If you took part last year we hope that you will want to take part again.
- If you haven't been in the 200+ Club before, why not have a go?
- You don't have to be a member of the Society to join in, so why not ask your family, friends or colleagues if they want to have a go too.

How do I join?

Simply choose one of the following ways...

1. [Complete the form overleaf](#) stating how many shares you would like. Send it with your payment to the Ménière's Society. To be included in the May draw please return your form by Wednesday 30 May 2018.
2. [Call us on 01306 876883](#) to join over the phone.
3. [Pay by standing order](#). This ensures you are always included in the 200+ Club and helps us reduce our administration costs. Your share numbers will stay the same each year unless you request otherwise.
NB: If you have already set up a standing order for the 200+ Club you will be entered automatically.
4. [Visit www.menieres.org.uk](http://www.menieres.org.uk) and go to our 'Online Shop' to buy and pay for shares online.

Will I get confirmation of my entry?

- Yes! Once we've received your completed form and payment your entry will be processed.
- A letter confirming your entry and share number(s) will be sent shortly after 1 June 2018.

How will I know if I've won?

- Winners are notified by post. Please notify us if you change your address during the year.
- Winning numbers are listed in Spin and on the Ménière's Society website.

2. The amount of your standing order payment.
3. Please ask your bank/building society to quote your name and membership number (if you are a member of the Society) followed by 200. For example: A SMITH 12345 200
4. If you already have a standing order for your membership payment, please let your bank know that the two standing orders will run concurrently.
5. Please email elaine@menieres.org.uk to let us know you have set this up so we can update our records.
